# Time to rethink preschool? We Think Not!

Recently, several news outlets have picked up on a study published by researchers at Vanderbilt University pointing to negative outcomes among sixth graders who had attended Tennessee's public pre-K program. The study found that, despite having attended a pre-K program deemed high-quality by national standards, participating students went on to have lower test scores in their elementary school years, were more likely to be placed in special education, and were more likely to have disciplinary records compared to their peers who did not attend the public pre-K. Articles have cited this study as "proof" that pre-K is harmful to children and therefore implementing universal pre-k would be a waste of taxpayer funds.

The study caused us more than a little concern and confusion as it simply did not fit with our lived experience (nor with many other studies that have preceded it, which cite numerous benefits of high-quality preschool education). To better understand what we were reading, we reached out to Dr. Steven Barnett, head of the National Institute for Early Education Research at Rutgers University. Dr. Barnett agrees that something has gone wrong in Tennessee's public schools, but he believes that to conclude that pre-K is the cause of these negative outcomes makes no sense. In a blog post responding to the study, Dr. Barnett wrote: "the research raises warnings about potential unintended negative consequences that are warranted, **but omissions of research and unjustified assumptions** make it a misleading and inadequate policy guide."

Barnett points out that there are so many variables not taken into account by the Vanderbilt study that it is illogical to conclude that pre-K is the source of problems that developed in subsequent years.

When we shared this study with our 27 partner preschool directors, the response was immediate. One director reached out to us to say she agreed with Dr. Barnett's many good points about why the study of the Tennessee program differed so dramatically from the preponderance of research about preschool education, adding, "those of us who live and breathe working with children and families see first-hand every day the positive difference a quality preschool education makes for children!"

In our experience, the Tennessee study overlooks the most obvious and essential outcome of high-quality preschool. Three and four-year-old children are people who have dignity and importance. They deserve to have affirming and productive experiences. Every opportunity to engage in these experiences provides its own reward. The staff, board, and volunteers at Preschool Advantage love to study and learn about the long term effects of high-quality preschool. However, we cannot underestimate the importance of the fact that today, 98 young learners are having a wonderful day, learning and growing because of the donors, partners and volunteers who comprise this special community.







Our volunteers have adapted very well to the online application review system put in place during the pandemic, and now one online transition has led to another. Equally exciting is that in-person family meetings are back! The family meeting provides an excellent opportunity for Committee

members (usually two at a time) to learn about each family's unique needs and to answer any questions they may have about the program. The information gathered by Committee members at these meetings, along with the application itself, helps Preschool Advantage place each child in a partner preschool that both the family and the Organization feel is a good fit. # SCHOOL SPOTLIGHT: THE DOGWOOD SCHOOL OF CHESTER PARTNER OF 5 YEARS



The Dogwood School, founded in 1967, in Chester, has partnered with Preschool Advantage for 5 years. Lisa Robbins, Ed.M., Director of the Dogwood School has always considered their outdoor playground space to be one of the school's strengths. There is plenty of room for children to run in the large open space, and mature trees offer shade on hot summer days. There are nooks and crannies to explore, and a brick patio perfect for tricycle riding.

When the pandemic hit in 2020, however, the school's playground took on a much bigger role in the children's education. Lisa took a closer look at how they could become creative in their learning space

while keeping students and faculty safe and without compromising the curriculum. The result: the indoor activities moved completely outdoors.

With tree stumps as chairs and custom-built outdoor chalkboards, the students found themselves in an outdoor

classroom immersed in nature full-time. Young learners observed up close the steady changes of the trees during the fall, the variations in weather and temperature, and the insects, birds and wildlife in and around their classroom. When spring came, they dug in the earth, planted seeds, watered and observed; two months later, they tasted their own 'homegrown' sugar snap peas, arugula, lettuces, basil and mint, and harvested sunflower seeds for the birds.



Dogwood students come to school each day dressed for outdoor learning, no matter the weather. Faculty helped parents identify articles of clothing to add to their child's wardrobe as well as where to find specific clothing items. As

pandemic restrictions ease, Dogwood continues to embrace the lessons nature has to teach. Their classroom without walls provides hands-on, sensory-based learning that is of enormous benefit to their students.

Robert Emmerich and Chelsea Perez of PwC have taken the lead on two key projects on our behalf. First, they helped us create a fully-online application



They have organized the information and formatted it into a living database where it can be analyzed by numerous pathways, including ethnicity, geography and income level. The result is a dynamic and user-friendly resource that accurately tells the story of the families we have served. This will be an invaluable tool as we embark on our next strategic plan and think about new ways to deliver both our program and our stories to prospective applicants and donors alike.


